The Internal Audit Division (IA) is an integral component of Manitoba's governance processes, and aligns with and supports the Deputy Ministers' Audit and Enterprise Risk Management Committee in the effective discharge of its corporate governance responsibilities. IA provides independent and objective assurance and advisory services to Manitoba that contribute to achieving the corporate goals of strong governance, risk management and control processes throughout the whole of government. IA's audit universe extends beyond other reporting entities and includes government departments and funded organizations where the funding agreement includes the right to audit; the Legislative Assembly, and large crown corporations and universities with their own internal audit functions are excluded.

- Must be able to travel occasionally within the Province of Manitoba
- Must have the ability to work evenings and weekends as required

- Analytical skills with the ability to work within undefined structures and to develop frameworks, including conceptualizing and solving unique and complex situations.
- Excellent interpersonal skills with the ability to develop respectful and collaborative working relationships with a variety of internal and external stakeholders.
- Strong political acumen demonstrated through experience providing strategic advice to senior leaders on complex topics and sensitive issues.
